**Sub: Invitation of Application for the Written Examination under  
Regulation 6 of CBLR, 2018 scheduled to be held in March, 2023**

Attention of all concerned is invited to the Notice dated 24<sup>th</sup> August, 2022 for "Customs Broker Examination 2023" issued by the National Academy of Customs, Indirect Taxes & Narcotics, Faridabad, (Annexure-I) available on official website [www.cbic.gov.in](http://www.cbic.gov.in) and [www.nacin.gov.in](http://www.nacin.gov.in) Applications as per format prescribed in Form-A (Annexure-II) along with documents (Annexure III) are invited from Indian Citizens to appear in the online written examination for issuance of license to act as a Customs Broker under Customs Brokers Licensing Regulations, 2018, as amended, for working at Air Cargo Complex (Import Shed)/(Export Shed)/ICD (Import)/ICD(Export) Tughlakabad, ICD Patparganj, Delhi and other ICDs falling within the jurisdiction of Commissioner, ICD, Patparganj.

2. Application in Form-A alongwith two passport size photos and self-attested documents on citizenship (Aadhaar/Passport/Voter Card), educational qualification, financial viability and other requirements along with the prescribed fee of Rs. 500/- (Rupees Five Hundred only) [paid through TR-6 Challan, to the Commissioner of Customs (Airport & General), New Custom House, New Delhi] is to be submitted in person at the Centralized Dak System Counter, Ground Floor in the office of the Commissioner of Customs (Airport & General), New Custom House, Near IGI Airport, New Delhi - 110037 or by Registered / Speed Post. The applications for the examination complete in all respect alongwith enclosures must reach this office between 18.10.2022 to 18.11.2022 (upto 06:00 PM) positively. Applications sent by post, received after the last date shall not be entertained.

Differently abled Candidates may mention their status alongwith their application form with supporting documents.

3. Before submitting the application, applicant should ensure the completeness of the application, as incomplete applications shall be rejected without any Notice/ Deficiency Memo issued to the applicant. No. correspondence in this regard shall be entertained by this office. Incomplete applications shall be summarily rejected.

4. The Regulation 5 of CBLR, 2018(as amended) prescribes the conditions to be fulfilled by the applicants which are extracted as under for information of applicants:-

*"The applicant for a license to act as a Customs Broker in a Customs Station, shall before applying to the Principal Commissioner of Customs or Commissioner of Customs, meet the following conditions that: —*

- (d) he is a citizen of India;*
- (b) he is a person of sound mind;*
- (c) he is not adjudicated as insolvent;*
- (d) he holds an Aadhaar number;*
- (e) he holds a valid PAN card;*
- (f) he has not been penalised for any offence under the Act; the Central Excise Act, 1944, the Finance Act, 1994, the Central Goods and Services Act, 2017 and Integrated Goods and Services Tax Act, 2017;*
- (g) he has neither been convicted by a competent court for an offence nor any criminal proceeding is pending against him in any court of law;*
- (h) an individual applicant or in case the applicant is a firm, its partner or in the case of a company, its director or an authorised employee who may handle the Customs work shall—*
  - (i) be a graduate from a recognized University; and*
  - (ii) possess a professional degree such as Masters or equivalent degree in Accounting, Finance or Management, CA/CS/MBA/LLM/ACMA/FCMA or Diploma in Customs Clearance work from any Institutes or University recognized by the Government or is having at least two years' experience in transacting Customs Broker work as G-Card holder;*
- (i) the applicant has financial viability as evidenced by a certificate issued by a Scheduled Bank or such other proof acceptable to the Principal Commissioner of Customs or Commissioner of Customs, as the case may be, in terms of possession of assets of value of not less than five lakhs rupees.*

(2) A retired Group A officer from the Indian Revenue Service (Customs and Central Excise) having a minimum of five years' experience in Group A' post shall also be eligible to apply for a license to act as a Customs Broker provided he satisfies the conditions specified at (a), (b), (c), (d), (e), (f), (g) and (i) of sub-regulation (1) above.

(3) The Principal Commissioner or Commissioner of Customs, as the case may be, may for the purpose of this regulation, make such enquiries to verify the eligibility of the applicant as he may deem fit before forwarding the application to National Academy of Customs, Indirect Taxes and Narcotics (NACIN). ”

5. Syllabus of written examination will be as per regulation 6(7) of CBLR, 2018.

6. Name of applicants found eligible to appear in examination will be displayed on the notice board and/or website of the respective Commissionerate **latest by 08.12.2022**.

7. Information regarding roll number, admit card and examination venue will be made available on the website of CBIC and NACIN websites [www.cbic.gov.in](http://www.cbic.gov.in) and [www.nacin.gov.in](http://www.nacin.gov.in) under the icon/tab <GSTP/CBLR Exam>. A link to download the admit card will also be provided therein. Admit cards shall also be sent by email to eligible applicants 12 days in advance before the date of examination. The written examination shall be held in the **Month of March-2023**.


8. The candidates have the option to answer either in Hindi or in-English.

9. Successful candidates will be called for an oral examination for which separate communication will be sent.

10. In case declaration and information submitted by the applicant are found to be incorrect the application shall be rejected or license, (if issued) shall be cancelled.
