**APPEAL**


All are aware that in the dastardly attack on security forces in Jammu and Kashmir on 14<sup>th</sup> February, 2019, 42 CRPF personnel were martyred and several others were injured when a suicide bomber rammed a vehicle carrying over 100kg of explosive into a CRPF convoy of 70 vehicles in Pulwama district.

“It is extremely distressing and disturbing to witness the loss of lives of the Soldiers who always stand for safety of our country. In this moment of grief, our sincere thoughts are with the families of our brave hearts”.

In order to help the families of 42 CRPF martyred, most of whom were young soldiers in the twenties, I sincerely appeal to all the officers posted at New Custom House, New Delhi to donate preferably one day salary voluntarily and individually through “BHARAT KE VEER” website or NIC eGov Mobile App, launched by Ministry of Home Affairs, Government of India. The Donations are allowed as an 100% deduction under Section 80G of Income Tax Act, 1961 and the donor may download the contribution certificate for their claim of Income Tax deduction / exemption under Section 80G of the Income Tax Act, 1961.\*

“The initiative by the department is a small gesture towards the families who have faced irreparable loss”.


The appeal is voluntary in nature for the officers & staff posted in Customs Zone / Customs (Prev.) Commissionerate, New Customs house, New Delhi.
